

Biometric Details (Photograph & Fingerprints) of the applicant shall be mandatorily captured upon arrival into India. Non-compliance to do so would lead to denial of entry into India. A determination that you are not eligible for e-Visa does not preclude you from applying for a regular Visa in Indian Mission.
